NOW THIS TRUST DEED WITNESSES AS FOLLOWS :



- (3) DFFICE of the Trust shall be situated at B-6/6, Sector-3, Rohini, Delhi-110085, which may be changed from time to time to such other place or places as the Trustee may deem fit and proper at their iscretion.





BOARD OF TRUSTEES



The Settler and Trustees shall constitute the Board of Trustees. The Trustees and Founder will elect out of themselves One person as a chairman and other person as secretary of the Board of Trustees for three years and under his chairmanship the meeting of the Board of Trustees shall conduct its proceedings.

> Board of Trustees shall appoint all types of employee i.e. Manager, supervisors, legal adviser and legal assistant, cashier, peon, chowkidar or any other staff required accoutant, to fulfill the objects of the trust. They have also powers to terminate the services or any staff as they may deem fit proper for the benefit of the Trust.


- (7) During the life time of Founder/Trustees, they can appoint their nominee and after their the appointed nominee and in case none is appointed then the legal heir will enjoy all the rights of Founder/Trustees and presently the Founder /Trustees are enjoying. This process of nomination of successor shall continue till the working of the Trust. to repeat the settler/Trustees or the nominees(s)shall continue to hold all those powers at present enjoyed by the Settler/Trustees.
- (8). The Board of Trustees will be the absolute incharge of the Trust and will exercise all the Discretionary and soverign powers.
- It is hereby declared that no part of trust property or its income shall be applied for any purpose other than the of the objects of the Trust as understood under the Income Tax Act, the time being in force, and the surplus funds if any Trust shall be invested as per the provisions of Income Tax Act.
- Number of the Trustees shall not be less than two and not more than eleven. Trustees shall not be trustees for their life time but any Trustees may resign by giving in writing to the Cotrustee. Appointment of Trustee(s) shall be only with the final approval of Board of Trustees.
- (11) The general management and control of the Trust properties and its affair shall be vested in the Trustees and the Trustees shall have power to do the all such acts as may be considered. necessary for the benefits of the Trust and/or management of its properties and affairs.
- (12) Without prejudice to any of the powers that the trustees may have under any law for the time being in force or to their general power for management the trustees shall have following powers :

- a) To manage the Trust, the Trust fund, Trust property and making admine relating to the Trust and and to do all acts. deeds and things necessary for the preservation, maintenance and management thereof and the affairs relating thereto or connected therewith, including the making of Rules and Regulation from time to time.
 - b) Tomapply and part of the Trust funds in acquiring movable and/or immovable properties and sell, mortgage, alienate or otherwise dispose off the same as they may thing fit and proper in the interest of truct.
 - To take on rent or lease, purchase or construct building C:) to construct, add, alter, demolish, maintain sell, dispose off, alienate or otherwise deal with any property comprising the Trust Fund, for the achievement of objects of the Trust.
 - To acquire purchase, very, sell convent, change, transfer, transpose or otherwise deal with all or any of the investment shares. Stock, debentures, Govt. Securities belonging including to the trust or representing the Trust Funds and to re-invest the same as the Trustees may deem fit and proper in accordance with the provisions of Income Tax Act.
 - e). To let out, demise any property comprised in the Trust fund for such period and at such rent discretion may think fit.
 - To apply and get registered under any law of Act of Boyt. of India or any State of India.
 - To accept donation, contribution, gifts and/or grant-in-aid either in money or in kind.
 - h) To enter into any contract and borrow money for the purposes of the Trust and management of its properties and assets
 - To open account(s) and give directions to transfer, endorse and sign government securities. Promissory notes, shares, debentures, securities, instruments etc. and all these accounts shall be operated by the Trustees jointly and/or severally as decided by them but the decision of the Founder/Nominee(s) of the successor(s) shall be final.
 - No appoint sub Committees comperising one Trustee or more for carrying out the objects and purpose of Trust and/or matter connected with the Trust and/or its affairs.
 - To institute suits, actions, and legal proceedings, to prefer appeals, to make applications or petitions, and to give affidavits, wherever necessary and to defend or compound , compromise, abandon, submit to arbitration or otherwise settle any suit, action claim, legal proceedings appeals, demands or dispute relating to Trust.
